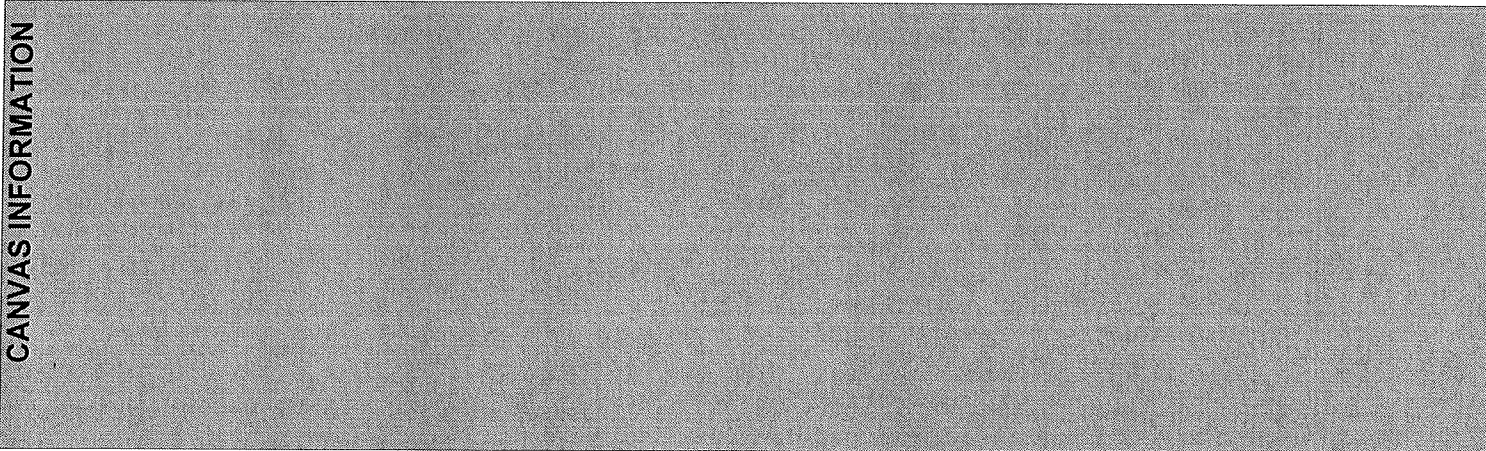

EVENT #04923, BWC, IN SUMMARY: WHILE ON ROUTINE PATROL R/O'S WERE WAIVED DOWN BY [REDACTED] (VICTIM AND COMPLAINANT) WHO RELATED THAT HE WAS CONFRONTED BY KEVIN HERRON(OFFENDER) INSIDE ROTHSCHILD LIQUOR MARTS ABOUT THE VICTIM OWING THE OFFENDER \$10.00 USC. THE VICTIM WAS UNABLE TO PAY THE OFFENDER. THE OFFENDER BECAME UPSET, TOOK OUT A RED FOLDING BOX CUTTER, AND STATED, "I AM GOING TO FUCK YOU UP," AND "I'M GONNA KILL YOU." THE VICTIM GAVE R/O'S A PHYSICAL DESCRIPTION AND R/O'S CONDUCTED A FLASH MESSAGE. R/O'S LOCATED AN INDIVIDUAL THAT MATCHED THE DESCRIPTION. 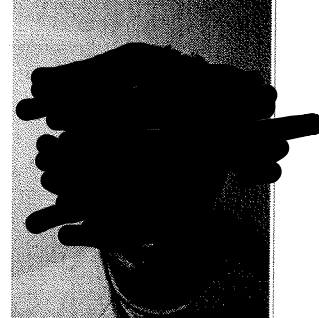

IN SUMMARY, R/O'S RESPONDED TO A CALL OF PERSON WITH A KNIFE AT THE LISTED ADDRESS. UPON ARRIVAL, R/O'S WERE MET BY [REDACTED] (VICTIM/COMPLAINT), WHO RELATED TO R/O'S THAT WHILE INSIDE ROTHSCHILD LIQUOR. HIM AND KEVIN HERRON (OFFENDER)HAD A VERBAL ALTERCATION ABOUT 10.00\$(USD). HE CONTINUED TO RELATE THAT WHEN HE TOLD THE OFFENDER HE WONT BE ABLE TO PAY HIM. THAT IS WHEN THE OFFENDER PULLED OUT A RED FOLDING BOX CUTER KNIFE AND SAID, "IM ABOUT FUCK YOU UP". THE OFFENDER FLED FROM THE LOCATION WHEN POLICE WERE CALLED. R/O'S TOURED THE AREA WITH A DESCRIPTION OF THE OFFENDER. THE OFFENDER WAS LOCATED AT 4003 S INDIANA AT THE CTA TRAIN STATION BY 0211 WHO OBSERVED ARRESTEE FITTING THE DESCRIPTION VIA FLASH MESSAGE. A/O'S CONDUCTED FIELD INTERVIEW AND CONDUCTED A PROTECTIVE PAT DOWN DUE TO THE CALL OF A PERSON WITH A KNIFE. ARRESTEE WAS FOUND WITH ONE RED FOLDING BOX CUTER IN HIS RIGHT SIDE FRONT PANTS POCKET ISR #000992401. ARRESTEE WAS ARRESTED UNDER SIGNED COMPLAINTS, AND TRANSPORTED AT 1024HRS TO DISTRICT 002 BY BEAT 211 FOR FURTHER INVESTIGATION. NO INJURIES WERE RECORDED FROM THIS INCIDENT.
