Dear Birks:

The Chicago Police Department is in receipt of your Freedom of Information Act (FOIA) request. In it, you state;

*" This is a request for documents under the Illinois Freedom of Information Act. I am requesting any records or notes publicly available for information on the follow case (I found the specifics on the Chicago data portal):*

*May 8, 2018*

*Interference with a Police Officer*

*O'Hare, Terminal*

*ID # - 11308682*

*Case # - JB255059"*

Your request was reviewed by the undersigned. Upon review, it was determined that your request is granted, in part, and denied in part. At this time you are being provided with the original case incident report and arrest report for the aforementioned RD number. Please be advised that certain information has been redacted from the documents pursuant to the following sections of the Freedom of Information Act.

Private information such as employee numbers, personal telephone numbers (residential and mobile/cell), home address, and driver's license numbers is exempt and has been redacted. The redacted information is exempt from disclosure under 5 ILCS 140/7(1)(b) of the Freedom of Information Act, which states "private information, unless disclosure is required by another provision of this Act, a State or federal law or court order" is exempt. The FOIA statute, in 5 ILCS 140/2(c-5), defines "private information" as follows:

"Private information" means unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, *home or personal telephone numbers*, and personal email addresses. Private information also includes *home address* and

personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person."

Dates of birth as well as names of individuals who incidentally appear in reports have been redacted under 5 ILCS 140/7(1)(c) which exempts personal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, unless the disclosure is consented to in writing by the individual subjects of the information. "Unwarranted invasion of personal privacy" means the disclosure of information that is highly personal or objectionable to a reasonable person and in which the disclosure of information that bears on the public duties of public employees and officials shall not be considered an invasion of personal privacy. Disclosure "would constitute a clearly unwarranted invasion of personal privacy" because a date of birth and a name "is highly personal or objectionable to a reasonable person" and the individual's "right to privacy outweighs any legitimate public interest in obtaining the information," as defined by FOIA. 5 ILCS 140/7(1)(c).

The name, address and other information that could be used to identify victims and complainants have been redacted. The redacted information is exempt from disclosure under 5 ILCS 140/7(1)(d) which exempts records in the possession of any public body created in the course of administrative enforcement proceedings, and any law enforcement or correctional agency for law enforcement purposes, but only to the extent that disclosure would:

(iv) unavoidably disclose the identity of a confidential source, confidential information furnished only by the confidential source, or persons who file complaints with or provide information to administrative, investigative, law enforcement, or penal agencies; except that the identities of witnesses to traffic accidents, traffic accident reports, and rescue reports shall be provided by agencies of local government, except when disclosure would interfere with an active criminal investigation conducted by the agency that is the recipient of the request;

You have the right to have a denial reviewed by the Public Access Counselor (PAC) at the Office of the Illinois Attorney General, 500 S. 2<sup>nd</sup> Street, Springfield, Illinois 62706, (877) 299-3642. You also have the right to seek judicial review of your denial by filing a lawsuit in Cook County Circuit Court.

INCIDENT NARRATIVE

Event #08054 P #180501509 No bwc. In summary: A/os were called to American Airlines Gate K12 for a disturbance with a passenger that was denied boarding being loud and abusive. American rescinded her ticket and A/os informed her she had to leave the secure area and escorted her out. While leaving she continually berated passersby causing them to become alarmed. Listed subject arrested on signed complaints by American Airlines security director [REDACTED] after she continued to be loud, abusive, derogatory while yelling "Fuck you bitch" and "you can suck my dick" repeatedly and refused to leave the premises, thereby causing a disturbance inside said terminal and the disruption of American Airlines and their agents to perform their functions. As subject was being placed under arrest, she began to flail and kick her legs at P.O. Torres #12763 and Sgt Oreilly #1269 and dropped herself to the ground in an attempt to defeat said arrest. Prior to said arrest as subject was being escorted through the terminal, a/os continued to attempt to deescalate the situation by referring arrestee to American Airlines management and offering to assist her to reach the manager. Subject taken into custody, asked repeatedly if she had been drinking or taking medication to which she said no and offered medical assistance but she refused. Subject transported to 050 for processing. Name check clear. No investigative alerts. No gipp. No gang.

#08054 IN SUMMARY: R.O. ASSIGNED TO A DISTURBANCE CALL AT AMERICAN AIRLINES GATE K 12. UPON ARRIVAL A.A. AGENT RELATED TO R.O. OFFENDER WAS NOT BEING ALLOWED TO BOARD THE FLIGHT TO BALTIMORE MD. BECAUSE SHE WAS IN A INTOXICATED STATE AND WAS BEING BELLIGERENT AND VERBALLY ABUSIVE TOWARDS THE AMERICAN AIRLINES GATE AGENT CALLING THE AGENTS RACISTS AND BITCHES REFUSING TO LEAVE THE GATE AREA. AT WHICH TIME OFFENDER WAS INFORMED BY R.O. SHE WILL NOT ABLE TO BOARD THE DEPARTING FLIGHT AND SHE WILL BE ESCORTED TO THE AMERICAN AIRLINES TICKET COUNTER TO REBOOK ANOTHER FLIGHT. WHILE ESCORTING THE OFFENDER TO THE A.A. R.O. TOLD OFFENDER TO CEASE SUCH ACTIONS AND SHE REFUSED CALLING R.O. RACIST SELLOUT YELLING FUCK YOU. WHEN OFFENDER ARRIVED TO THE UNSECURED A.A. COUNTER SHE CONTINUED WITH HER DISORDERLY ACTIONS AND AFTER SEVERAL ATTEMPTS BY R.O. TO DEESCALATE THE SITUATION OFFENDER WAS PLACED UNDER ARREST AFTER A.A. CORPORATE SECURITY MANAGER [REDACTED] SIGNED COMPLAINTS WITNESSING THE DISTURBANCE. WHILE ATTEMPTING TO PLACE HANDCUFFS ON THE OFFENDER, OFFENDER DROPPED TO THE FLOOR AND BEGAN KICKING AT R.O. ATTEMPTING TO DEFEAT THE ARREST. AT WHICH TIME R.O. CALLED FOR A SQUADROL TRANSPORT.
