CASE REPORT NARRATIVE

In Summary: The complainant (Vera Kisliak) walked into the Buffalo Grove Police Station to make a report of a domestic family problem. Vera stated her husband (Andrei Kisliak) has taken possession of the keys of all four of their vehicles, has disconnected service to her cell phone, has changed the WIFI password to the house and has taken full control of their finances leaving her with no money. Vera stated the vehicles along with the cell phone service and the house bills are in Andrei's name. Vera told us Andrei has done this in the past, however they were able to work their problems out. Vera stated he has also used her social security to open one credit card in which she is aware of but is unsure if he has opened other accounts in her name.

Vera stated they have two young children together and believes Andrei is speaking with a divorce attorney because she overheard a phone conversation from a few days ago. As of recent, Vera said she started working a new job but has been using a majority of her money for transportation to and from work. Vera was seeking legal assistance along with any other resources or services BGPD may be able to offer. She mentioned she could possibly need the assistance of a Russian translator due to her limited English. I provided Vera with BGPD social worker's information along with information on contacting the three major credit bureaus. Vera mentioned due to her cell phone service being disconnected, email currently is the best way to contact her. She was satisfied and stated she would contact the BGPD social worker for information.

CASE REPORT NARRATIVE

IN SUMMARY:

Ofc. Kroski and I responded to the listed address for a report of domestic trouble. Upon arrival, we met with the complainant, Vera Kisliak. Vera states she and her husband, Andrei Kisliak, were in the process of getting a divorce. She was sleeping when she heard some sounds downstairs. When she went to investigate, Vera discovered Andrei was in the basement with another woman and believed they were Vera stated her and Andrei exchanged words and then she called the police. The other female subject left the scene as we arrived. Two children, ages 7 and 4, were sleeping during this incident.

Andrei advised he was in the process of getting a divorce with his wife, Vera. He stated he came back home with another female he was interested in. While in the basement with the female, Andrei advised Vera came downstairs and became upset about the situation. Andrei advised he didn't say anything to Vera and nothing physical occurred between him and Vera.

Vera advised she has already been in contact with PSW Wilson and has an appointment with for assistance with domestic related issues. Vera advised Andrei had her served with divorce papers on 07/27/22. She further stated she has no family or anywhere else to go at this time. She also confirmed nothing physical occurred between her and Andrei during this incident. Both parties agreed to stay separated for the night and were provided with report number information. CASE REPORT NARRATIVE

In summary, Andrei Kisliak called 911 to report that his wife, Vera Kisliak (divorce pending) stole the keys to his BMW bearing IL registration

He stated he was advised by his attorney via email to leave a house key and the key to the BMW bearing IL on the kitchen counter. I observed a house key and a broken BMW key on the kitchen counter.

He stated he kept the key to his other BMW on the kitchen counter and said that when he came downstairs the key was missing. He accused Vera of stealing the key. I advised Andrei that because they are still married she has the same ownership of the key as he does. She cannot steal what belongs to both of them. He requested to document that she took the key to his car without his permission. I called Vera and left a voice message.

At 1922 hours Vera called 911 to report that she cannot get into the house because Andrei locked her out. I met with Vera and her at the side of the driveway. She told me that Andrei changed the codes on the garage and rear doors. She showed me a court order that stated Andrei was supposed to leave her a house key and the key to her BMW on the kitchen counter. She told me the key to the BMW was broken and the car was out of fuel. She stated she is in fear for her and her kid's safety. She was unable to explain why and stated that there has never been a physical altercation between them. She requested I speak with Andrei and tell him to stay away from her. Vera stated she will stay away from Andrei. I asked Vera about the missing key and she stated at the advise of her attorney she took the key.

I spoke with Andrei who stated he did not change the codes to the doors, but said he deactivated them because he feared someone may hack them. The front door is the only door that is keyed

Andrei stated he would stay away from Vera.

Ms. Kisliak explained they are in the process of divorce and while the case is on-going, she is currently residing in a different part of the martial home. Mr. Kisliak kept knocking on Ms. Kisliak's bedroom door and yelling at her while their two young children were playing in their bedroom. Ms. Kisliak stated just recently she was awarded a vehicle during court proceedings and wished to leave with the children to run errands. Ms. Kisliak stated

In summary,

Sgt. Turano, Ofc. Sarat and I responded to Acacia Terrace for a domestic. Upon arrival, we met with the complainant Vera Kisliak on the driveway. She explained, she went into her husband's room and started asking him about their children's day care plans for the school

year. She explained, he started yelling at her and threatened to kill her. She stated, she tried to record his behavior on her phone, but he grabbed her phone and threw it to the ground. She did show us a phone that had a damaged screen.

While we were speaking with Vera, Andrei came outside and stood on the porch. We went and spoke with him. He confirmed the part about her coming into his bedroom, but stated she started screaming at him about taking the kids out of public school and putting them in day care. He admitted to yelling back at her, but denied threatening to kill her or damaging the phone. He went back inside his house and retreated to his bedroom.

We asked Vera if she had any evidence to substantiate her claim and she stated she did not. She said she was scared to stay at the house tonight, so we offered to take her to a hotel. She did not wish to leave for the night. We suggested she talks to her lawyer about an Order of protection. She stated she would contact her lawyer first thing in the morning. We stood by while she entered the residence to make sure there were no further arguments.

He told me that some unknown female picked up his child. I asked him if he was hitting his children and he denied it. He stated he took his daughters to get their hair done and then out for ice cream.

I spoke with the complainant who stated she was in the bar area when she observed the two girls sitting at the bar from the corner of her eye. She did not see him hitting the girls. She said the father left the girls alone at the bar for at least 20 minutes. She spoke with the 6-year-old juvenile who told her she was afraid to go home. She told that the father Kisliak hits them and their mother at home. She said he hits her in the arm near the biceps. She said she did not see any bruises on the juveniles. She then called 911.

I spoke with the 6-year-old juvenile if front of Kisliak. She stated that her father does not hit her. I asked her if she was afraid to go home and she said no. But she placed her thumb in between her two fingers. I asked what does that mean and she stated that her father pinches her nose.

Kisliak's friend, came to Mistiko stated he was there to give Kisliak and his daughters a ride home. Kisliak stated he asked him to come because his car is being left in the parking lot for his mechanic to pick up.

Prior to leaving, Mistiko's owner approached me and stated that Kisliak has been there with the girls for several hours and that the girls were happy and nothing was wrong. He was not sure why the complainant called 911.

In Summary: Vera Kisliak stated she suspects her husband took her vehicle from their home's driveway between the hours of 0020 - 0800 on 09/05/2022. Vera told me she and her husband (Andrei Kisliak) are in the process of getting a divorce and she has a court order stating Andrei must provide her with their 2011 BMW Alpina (IL plates

According to Vera, her attorney reached out to Andrei's attorney via telephone on 09/06/2022, regarding this incident and Andrei denied taking the vehicle and does not know where it is. Vera told me the vehicle is always locked and there are two keys and Andrei is in possession of one of the keys.

Vera stated her house has a Ring doorbell security camera that may show Andrei taking the vehicle from the driveway, however Andrei has blocked her from accessing the camera. I spoke with their neighbor Acacia Ter) who also has a Ring doorbell security camera however he stated his cameras settings are set to only record when motion is detected on his properties front steps and the camera would not have captured any footage from the Kisliak's driveway.

I spoke with Andrei via telephone who denied taking the vehicle and requested I do not report the vehicle as stolen because he wants to "look for it" with Vera. Andrei stated he doesn't have the spare key and since he cant have any contact with Vera per court order, he requested if I can ask Vera to search the home for the spare key, and if found, ask for her to turn it into the Buffalo Grove police department so he can retrieve it from the station. I explained to Andrei that if he and Vera have no knowledge of how their vehicle went missing from their driveway, I can report it as stolen via LEADS and he denied my request a second time and stated he will look for it himself. I relayed Andrei's message to Vera.

Per Vera's attorney she was advised to document this incident because he is trying to schedule an emergency court hearing for this week. I provided Vera with a Buffalo Grove police report number and advised her to contact the police with any new information.

Andrei said he suspects Vera may have hid his Belarus passport. Both parties were advised to work with their attorneys regarding any personal property.

In summary: Lt. Nugent and I met with Vera Kisliak at her home, where she explained her estranged husband, Andrei Kisliak, was upstairs in bed, which violates the order of protection (OOP) Vera has against Andrei (LEADS #:

The OOP is valid, having been served by Lake County Deputy Heiny #1267 on 09/14/22 in open court (expires 10/03/22).

I spoke with Vera who explained her two young children were asleep in the home and unaware of the current situation.

Andrei was located in the primary bedroom; he requested to be examined by Buffalo Grove paramedics, who attempted to tend to Andrei, but Andrei was uncooperative. Andrei refused to put shoes on, walk to the ambulance, or be further treated by paramedics. Andrei was given numerous opportunities to cooperate, put on different clothing and more, before he was ultimately placed into custody for violating the OOP. The handcuffs were double locked and checked for proper fit.

Ofc. Hill and I escorted Andrei to my squad car, at which time I activated my camera system. Due to Andrei's uncooperativeness, paramedics read Andrei's refusal to him, and Lt. Nugent was required to sign on Andrei's behalf.

I transported Andrei to the station for processing which occurred without incident. Andrei appeared via zoom for bond court and was given a \$5000 bond (D -10%) and subsequently transported to the Lake County jail.
