In summary, Mr. Kisliak called BSGPD for assistance removing his fiancée from his house. He advised NWCDs that she was refusing to leave after an argument.

Ofc. Rossi and I responded to the address. We found Ms. [redacted] in the street outside the house. Initially, Ms. [redacted], stated that her fiancée was refusing to let her have her belongings as she was trying to leave his house. Ofc. Rossi and I went back to speak to Mr. Kisliak. I asked him again what happened tonight, and he replied just an argument. He denied any physical contact with Ms. [redacted] I informed him of her allegations, and he then stated that he may have scratched her while trying to

They were smoking cigarettes near the Southeast corner of the building when a then unidentified subject pulled up in a vehicle and confronted them about smoking. They said this subject was very rude and confrontational and eventually identified himself as a janitor for the park district. This subject was identified as [redacted] called the police and Ofc. Pakaski arrived to speak to the parties involved (See CFS 12-8316)

Mr. Kisliak said after this incident he went home and parked his car in the garage. This morning he drove to work and parked his car. He said he was at work for about an hour when a co-worker inquired about the scratch on his vehicle. It was then that Mr. Kisliak first learned of the damage and suspected Mr. [redacted] of causing it.

I called Mr. [redacted]. He said he was working at Alcott Center and would stop by to talk to me. After he arrived, Mr. [redacted] told me about the incident. He said he went to Emmerich to lower the US Flag to half staff. He saw two vehicles parked near the Southeast corner of the building in a no parking zone and two people smoking. He said he very nicely advised them they couldn't park there and that there was no smoking on park district property. He said the male subject, Mr. Kisliak instantly became confrontational with him and questioned who he was by saying "who the fuck are you?" After this, [redacted] called the police.

Mr. [redacted] denied causing any damage to Mr. Kisliak's vehicle. Mr. [redacted] let me inspect any keys in his possession. I did not see any indications they had been used to scratch a vehicle. Also, there is no video surveillance on the East side of the building that would help to substantiate either parties version of events. Mr. [redacted] was given the police report number should park district officials need to follow up on this incident.

I called Mr. Kisliak and advised him of my findings. He said he would handle this through his insurance company and thanked me for the follow-up.

I responded to the listed location for a suspicious subject who was in the caller's front yard. The call was delayed by about 20 minutes and the subject and vehicle had left the area and were last seen N/B on Acacia towards Port Clinton Rd. Upon my arrival, I met with the caller (Kisliak) who said she was upstairs in her daughter's bedroom when she noticed a pick-up truck parked in front of her house. The truck was facing N/B, against the flow of traffic, and was directly in front of he mailbox. She said she saw a male subject wearing a hood walking across the front of her house approaching her front door. She went downstairs and observed the subject standing in the grass and looking in her windows, just to the south of her front door. The subject never knocked on the door or windows or made any other attempt to make contact with her. The subject quickly returned to the truck and did something, then walked to the north side of the house out of her view. The subject went back to the truck and entered the driver's door and left the area.

Kisliak took pictures of the truck while she was standing in the entrance of her front door and the subject was back inside of the truck. The truck is too far away so a license plate is not visible in the photos. Kisliak believes the truck was blue but said it was possibly black and it had a loud muffler. In the pictures she took, the headlights are on, the taillights are both lit and the rear license plate light appears to be very bright. I advised the other BGPD units of the situation and vehicle and they checked the area but were unable to locate the vehicle or subjects.

Kisliak said they have a lot of cameras on the exterior of their home but none of them are working right now. She said she called her husband once the vehicle left and he told her to call 911 which was why there was a 20 minutes delay. Kisliak said she saw a Facebook post about a recent residential burglary in the area and she fears they are being watched and targeted. We discussed ways she can protect her home and family. I also encouraged her to call 911 immediately next time instead of calling her husband first. Sgt. Positano and I walked around the exterior of Kisliak's home and didn't notice any pry marks or anything to indicate an attempted burglary.

After speaking with Kisliak I went across the street and spoke with [redacted] because I noticed she was just arriving home as the truck was parked in front of the house. [redacted] said she noticed the truck parked in front and she said there were 2 men inside (no further description) and the truck was blue with an open bed. She confirmed the truck left N/B on Acacia while she was parked in her driveway and still in her car [redacted] daughter said she saw a pick-up truck parked in a similar spot in front of Kisliak's house last week between 1530-1600 on either 10/23 or 10/24. She said there were 2 men sitting inside of the truck on that day as well. I spoke at length with [redacted] and her daughter about being aware of who is parked on the street when they come and go and ways to protect their home and family. [redacted] said they will call 911 if they see the pick-up truck again in the area. The [redacted] family does not have any cameras in or around their home.
