EVENT #1908313343, THIS WAS A BODY WORN CAMERA RECORDED INCIDENT. IN SUMMARY, ON ROUTINE PATROL, R/O'S OBSERVED HERBERT EVANS (OFFENDER) APPROACHED A ROD-IRON GATED FENCE AND MADE A HAND-TO-HAND TRANSACTION WITH AN UNKNOWN FEMALE SUBJECT AT THE ABOVE LOCATION. OFFENDER THEN ENTERED THE ABOVE PARKED VEHICLE MAKING FURTIVE MOVEMENTS AT WHICH TIME R/O'S CONDUCTED AN INVESTIGATORY STOP. DURING THE FIELD INTERVIEW, R/O'S ASKED IF THE HAND-TO-HAND TRANSACTION WAS NARCOTICS RELATED AT WHICH TIME OFFENDER GAVE R/O'S CONSENT TO SEARCH HIS VEHICLE AND PERSON FOR SUSPECT NARCOTICS. 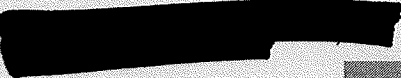



	<p>EVENT #1908313343, THIS WAS A BODY WORN CAMERA RECORDED INCIDENT AND NOT REVIEWED PRIOR TO COMPLETING THE ARREST REPORT. IN SUMMARY, WHILE A/O'S WERE PATROLLING NEAR A KNOWN GANG CONFLICT AND NARCOTICS LOITERING HOT SPOT AREA (18/19-012-4&1-001) AND NEAR THE ST. STEPHENS TERRACE APARTMENTS, A/O'S OBSERVED ABOVE SUBJECT(HERBERT EVANS) APPROACH AN IRON GATED FENCE AND MADE A HAND-TO-HAND SALES TRANSACTION WITH AN UNKNOWN FEMALE SUBJECT AT THE ABOVE LOCATION WHERE BOTH SUBJECTS PLACED SOMETHING INSIDE THEIR POCKETS. SUBJECT(HERBERT EVANS) THEN ENTERED THE ABOVE PARKED VEHICLE. WHILE SUBJECT WAS INSIDE THE PARKED VEHICLE, A/O'S OBSERVED SUBJECT WHO APPEARED TO BE USING HIS LEFT HAND REACHING AND CONCEALING SOMETHING SEVERAL TIMES INSIDE THE DRIVER SIDE FLOOR AREA AT WHICH TIME A/O'S CONDUCTED AN INVESTIGATORY STOP.
